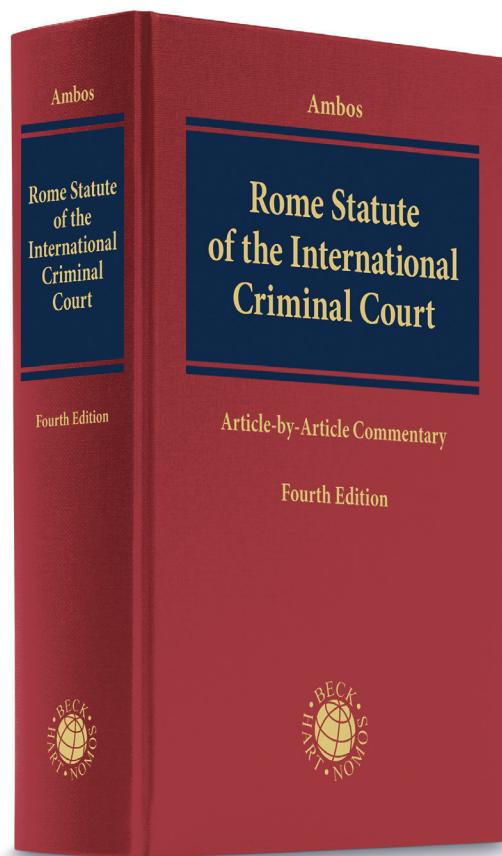

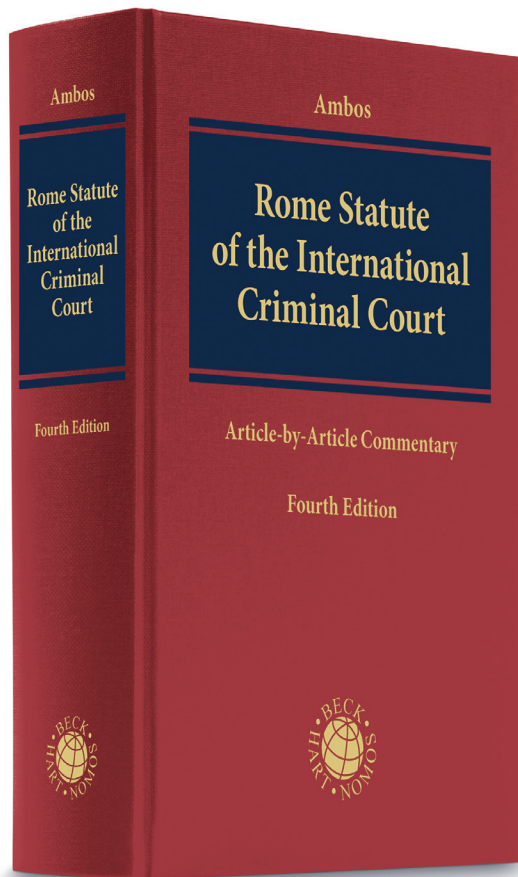

## About the book:

The Commentary, founded by the late Otto Triffterer more than 20 years ago, is the leading commentary on the Rome Statute and legal framework of the International Criminal Court (ICC). The editor and a number of eminent legal practitioners and scholars in the field of international criminal law give a detailed article-by-article analysis of the Statute of the ICC. The commentary aims at explaining the content of the various articles in a broader sense, including their drafting history, their interpretation through ICC case law, their impact on International Criminal Law, and their relation with other sources of the ICC such as the Rules of Procedure and Evidence, the Regulations of the Court and the Prosecution.

**This fourth edition** of the commentary has been thoroughly revised, updated, extended, and complemented with some further resources. It contains up-to-date case law (including a Table of Cases), literature and legislative developments at the ICC. Due to the burgeoning body of International Criminal Law, clarity and structure of presentation as well as greater consistency was a major objective of this new edition. It is hoped that the Commentary will continue to provide a useful guide for both practitioners and academics in various capacities.

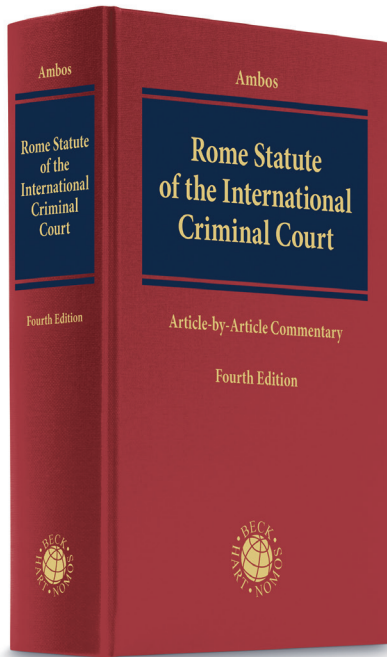
